CCAEJ Supports Yvette Vargas' Fellowship Presentation on Human Rights and Environmental Challenges in the Inland Empire



Over this summer, Yvette Vargas has diligently been collecting data and information for her fellowship program through the Human Rights Center at the University of California Berkeley. This fellowship program allows students to travel to remote locations to study and report back about human rights violations, and the necessity for adequate coverage and exposure on these injustices. Yvette focused on the inland region and its crisis dealing with warehouse proliferation and air pollution. She wanted to create a prototype database for CCAEJ to readily distribute information about the inland region; this whole process culminated in a presentation on October 12th where Yvette delivered her report. Shane Ysais and Steven Carretero both attended as representatives from CCAEJ for what was a wonderful presentation of not just events but of all of the participants in this program. It was so moving and so emotionally intense. We have nothing but gratitude for all the stories shared, and all of the information gathered, we want to thank Yvette and everyone for inviting us to this wonderful day and we wanna also extend our gratitude for all the work given into this program and given to CCAEJ. It's these types of collaborations that push our movement forward and continue to raise awareness for human rights around the world.





NINE DIRTY POWER PLANTS LIKELY VIOLATING FEDERAL AIR STANDARDS, COMMUNITY GROUPS DEMAND SHUTDOWN



INDUSTRY, Calif. — A recent report has sounded the alarm on the Walnut Creek Energy Park in Los Angeles County, revealing the facility's likely violation of federal air quality standards. As members of the Regenerate California coalition, CCAEJ joins environmental justice organizations across the state in calling for the immediate shutdown of this methane gas power plant, which endangers nearby neighborhoods and schools.

The report, "The Notorious Nine: Gas Plant Pollution in Environmental Justice Communities," highlights nine gas-fired power plants across California that exceed federal limits on nitrogen oxide (NOx) emissions, with Walnut Creek identified as the highest-risk facility.

"Toxic NOx pollution from this plant, combined with emissions from nearby railroads, warehouses, and the 60 Freeway, exacerbates asthma and other health issues in an already overburdened community," said Tyler Valdes, Energy Justice Manager with the California Environmental Justice Alliance (CEJA).



Impact on Our Most Vulnerable Communities

The surrounding community, which is 80% Hispanic, already suffers from some of the highest pollution levels in California. Two elementary schools—Mesa Robles and Grazide—are within the plant's most affected zone. "Our children are breathing in pollution that causes asthma, heart disease, and other serious health problems," said Dr. Alfred L. Glover, a local public health advocate. "This cannot continue."

A Clear Path Forward

The findings coincide with the EPA's push to tighten NOx emissions standards nationwide. Along with other coalition partners, CCAEJ is advocating for immediate action to address this environmental and public health crisis. Julia Dowell, Senior Organizer with Sierra Club's Electric Sector Campaign, emphasized the urgency of transitioning to renewable energy: "We must end pollution from dirty fossil fuels and build a clean, renewable energy future."

Policy Recommendations

- -The report offers actionable steps to tackle NOx pollution:
- -Shut down the most polluting gas plants in disadvantaged communities.
- -Require transparent emissions reporting from all gas plants.
- -Expand monitoring of startup/shutdown emissions, where NOx spikes dramatically.
- -Accelerate California's transition to renewable energy sources.

Standing United for Justice

Regenerate California, a coalition co-led by CEJA and the Sierra Club, brings together organizations like CCAEJ to advocate for a just transition away from gas-fired power plants. We are committed to ensuring that vulnerable communities are no longer the dumping ground for pollution.

Rialto's Big Win:

Rialto Council Upholds Community Appeal, Advances Environmental Justice



In a groundbreaking victory for environmental justice, the Rialto City Council unanimously upheld CCAEJ's community appeal against a controversial warehouse development. This decision marks a significant win for Rialto residents, who rallied together to protect their health, safety, and community well-being.

The proposed warehouse, planned for the corner of Locust Avenue and West Coast Boulevard, would have been just 60-80 feet from homes, posing serious risks by increasing truck traffic and pollution—especially along school routes. Thanks to the tireless efforts of CCAEJ and the voices of over 70% of impacted community members, the project has been halted.

Ana Gonzalez, Executive Director of CCAEJ and a Rialto resident, celebrated the council's decision:

"This has been one of the most heartwarming victories for CCAEJ and the community of Rialto this year. Witnessing the happiness in the eyes of our community members and knowing the health of my family and neighbors is now better protected makes our efforts incredibly worthwhile."

Special thanks go to community leaders Kelly Valencia, Raul Valencia, Yesenia Ramos, and the more than 40 families who submitted letters and petitions urging the council to prioritize public health and safety.

In addition, the council approved a critical update to its general plan, introducing an Environmental Justice Element aligned with SB1000. This step ensures that Rialto's neighborhoods will be designed with health, inclusivity, and sustainability in mind.

CCAEJ extends heartfelt gratitude to everyone who participated, attended meetings, and supported this campaign. Together, we've shown that community power can lead to real change!



But even with this amazing victory, developers have been working behind the scenes to reintroduce this warehouse. CCAEJ is fully committed to seeing this decision upheld and will continue to fight for the will of the community who continues to voice their opposition of this warehouse.



CCAEJ and Allies Push AQMD for Cleaner Air:

Vital Rules Delayed, But Hope Remains for 2025



"What do we want? Clean air! When do we want it? Right now!" On Friday. December 6, CCAEJ and nearly 100 other coalition partners delivered a strong message to the governing board of the South Coast Air Quality Management District to let them know that they are behind on passing vital rules and regulations to protect the air quality in the South Coast Air Basin, namely the Rule 2304 (Ports ISR) and Rules 1111 and 1121 to regulate large boilers. After standing up for the community earlier this year and approving the Railyard ISR in August, we were hopeful that the AQMD would act judiciously and also pass the Ports ISR before the end of 2024.

Unfortunately, we are not going to receive that relief in 2024, but we delivered the message that we are anxiously awaiting them to approve it by the end of the first guarter of 2025. The Ports ISR is not just another rule to put on the books, it is a vital action needed to bring the region into compliance with the Clean Air Act as the San Pedro Bay ports of LA and Long Beach are some of the single biggest contributors to air pollution in the region.

Similarly, Rules 1111 and 1121 would save more lives through better air quality not just in the region at large, but also in homes. It too has been delayed, though "only" until February this time. Nevertheless, we were able to stress the importance of getting those rules passed as they too are vital for meeting federal clean air standards as well as delivering lower costs to consumers over the longer term. We and other coalition partners look forward to returning to the AQMD board in 2025, not to once again ask them to pass the rules, but to celebrate a brighter future as they are approved and will provide cleaner air for all.





Bloomington Community Advocacy Shines

C.A.T.'s Mobilize During NOP Comment Period



On November 14th, we gathered with our Bloomington Community Action Team (CAT) to discuss pressing environmental justice issues. Key topics included updates on our air monitoring program—critical for Bloomington due to heavy industrial development—and community concerns like upcoming street closures and prolonged public safety power shutoffs, with some areas experiencing two days without power.

Our CAT meetings are collaborative spaces where community members raise concerns, brainstorm solutions, and share resources. We also provided updates on the recirculation of the Bloomington Business Park Draft Environmental Impact Report Notice of Preparation. The meeting was highly productive, and we're excited to continue working alongside the community to create impactful change.

After securing a hard-fought victory in our CEQA lawsuit against Howard Industrial Partners and the County of San Bernardino, we entered a crucial phase of the process: the Notice of Preparation (NOP) comment period. This victory requires the developer to revise and recirculate their Environmental Impact Report (EIR) to address the deficiencies identified by the court.

The NOP comment period presented a critical opportunity for the community to shape

the future of this project by raising concerns, advocating for thorough environmental analyses, and suggesting how these analyses should be conducted. With just 30 days to act, we rallied together to ensure our voices were heard loud and clear.

CCAEJ hosted a series of community workshops, creating a supportive space where residents could share their stories, understand the EIR process, and craft impactful comment letters. We provided resources and guidance to help community members highlight the ongoing and future harms of the project, including its impacts on air quality, greenhouse gas emissions, energy usage, noise, and overall community well-being.





Through these efforts, 28 community members submitted detailed comment letters, each bringing unique perspectives and raising critical concerns. This collective action demonstrated the power of a united community standing up for environmental justice, accountability, and the health of our neighborhoods.
